## **SAFETY AT THE RINK**

### **OBLIGATIONS**

As with all sports, ice skating can be dangerous, with risk of injury.

All persons at the rink, including members of the general public, have an obligation to ensure the health and safety of themselves and all others at the rink. The evaluation of all risks, both prior to entry and when utilizing the rink facilities, will assist in discharging this obligation.

Particular consideration should be given to the state of the ice surface, which may vary with changes in atmospheric conditions. Consideration should be given to this prior to the commencement of ice skating.

Skaters at all times skate at their own risk.

### **VIGILANCE**

By engaging in ice skating, skaters and spectators are deemed to have knowledge of, and assume the inherent risks of, ice skating which include but are not limited to the following:

- (a) Injuries that result from collisions or contact with other skaters or other individuals who are on the skating surface;
- (b) Injuries that result from falls; and
- (c) Injuries that involve objects that are properly within the intended path of travel of the skater.

Skaters and spectators are responsible for the identification of risks to which they may be exposed.

# SKATERS CODE OF CONDUCT AND ASSUMPTION OF RISK AGREEMENT

## SKATERS AND SPECTATORS UNDERSTAND AND AGREE TO ALL OF THE FOLLOWING:

Maintain reasonable control of his/her speed and course at all times.

Read and abide by all posted signs and warnings and co-operate with the rink staff.

Maintain a proper lookout to avoid other skaters, objects or conditions on the surface of the rink.

Accept responsibility for know the range of his/her ability while on skates and skate within the limits.

Refrain from skating while under the influence of drugs, alcohol or other controlled substances.

Leave the ice surface when resurfacing maintenance is taking place.

Refrain from taking food and drinks onto the rink surface or surrounding barrier or railings.

Refrain from acting in a manner that may cause or contribute to injury of themselves or any other persons.

Refrain from throwing or leaving objects on the rink surface.

Refrain from instigating or becoming involved in any type of altercations with any other skater or spectator and shall not engage in abusive, abrasive or disorderly conduct.

**Assumption of risk:** By engaging in skating, skaters and spectators are deemed to have knowledge of, and assume the inherent risks of skating which include but are not limited to the following:

a) Injuries that result from collisions or contact with other skaters or other individuals who are on the skating surface.

b) Injuries that result from falls.

c) Injuries that involve objects or artificial structures that are properly within intended path of travel of the skaters.
